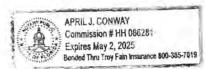

#### A. CALL TO ORDER

The February 7, 2022, Regular Board Meeting of the Sonoma Bay Community Development District (the "District") was called to order at 10:41 a.m. at the Sonoma Bay Clubhouse located at 3600 Sonoma Drive, Riviera Beach, Florida 33404.

#### B. PROOF OF PUBLICATION

It was determined that the attendance of Vice Chairperson Consuella Bailey and Supervisors Sherman Cogle and Rokibul Hasan constituted a quorum and it was in order to proceed with the meeting.
