There were no additions or deletions to the agenda.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES 1. March 13, 2023, Regular Board Meeting

The minutes of the March 13, 2023, Regular Board Meeting were presented for Board consideration.

A **motion** was made by Mr. Hasan, seconded by Ms. Dennis and passed unanimously approving the minutes of the March 13, 2023, Regular Board Meeting, as presented.

There were no Old Business items to come before the Board.

H. NEW BUSINESS

1. Consider Resolution No. 2023-01 – Adopting a Fiscal Year 2023/2024 Proposed Budget

Resolution No. 2023-01 was presented, entitled:

RESOLUTION NO. 2023-01

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE SONOMA BAY COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET FOR FISCAL YEAR 2023/2024; AND PROVIDING AN EFFECTIVE DATE.

In response to the Board's request for additional time to review the proposed budget, Ms. Bethel asked if there were any questions. A lengthy discussion ensued. Ms. Spence stated that the police department was scheduled to come out and do a complimentary security survey but had cancelled. Ms. Spence is concerned about the security in the community and would like to know how the CDD and HOA could work together to resolve this concern. Mr. Gregory stated that the CDD could pay for a guarded gatehouse and the HOA could take over the roving security guard. Ms. Bethel advised that they could increase the security line item and can make changes to decrease it at a later time. Ms. Bethel will get some security proposals for the manned guard gate and set up a security workshop between the CDD and the HOA. If the HOA is interested, then the workshop will take place during the next meeting in May. If not, staff is directed to cancel May's meeting.

Mr. Gregory indicated he could address the sidewalk question Ms. Spence had inquired about. Ms. Spence filled the Board in about the sidewalks needing repairs and the fact that they are a hazard to residents. Mr. Gregory stated the CDD was not responsibility for the sidewalks but maybe the HOA is.

A **motion** was made by Ms. Spence, seconded by Mr. Hasan and passed unanimously adopting Resolution No. 2023-01, setting the Public Hearing for June 12, 2023.

Ms. Bethel directed the Board's attention to the financials in the meeting booklet. She requested that the Board look over the information and let her know of any questions.

Ms. Spence asked about legal fees to which Mr. Gregory responded.

K. ADJOURNMENT

There being no further business to come before the Board, the Regular Board Meeting was adjourned at 11:17 a.m. on a **motion** made by Mr. Hasan, seconded by Ms. Dennis and passed unanimously.

1. Ability of Personnel (10 Points).
