### A. CALL TO ORDER

The February 10, 2024, Regular Board Meeting of the Sonoma Bay Community Development District (the "District") was called to order at 9:06 a.m. in the Sonoma Bay Clubhouse located at 3600 Sonoma Drive, Riviera Beach, Florida 33404.

### **B. PROOF OF PUBLICATION**

Proof of publication was presented which stated that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on January 31, 2025, as part of the District's REVISED Fiscal Year 2024/2025 Meeting Schedule, as legally required.

### C. ESTABLISH A QUORUM

It was determined that the attendance of Chairperson Dorothy Dennis, Vice Chairperson Jordia Spence and Supervisors Pamela Carter and Rokibul Hasan constituted a quorum and it was in order to proceed with the meeting.

A **motion** was made by Mr. Hasan, seconded by Ms. Dennis and passed unanimously approving the minutes of the January 13, 2025, Regular Board Meeting, as presented.

### G. OLD BUSINESS

1. Discussion Regarding Letter from Sonoma Bay HOA

• Review Revised Agreement between District and HOA

Mr. Geroge indicated that he needed further clarification on the direction the Board would like to take. The agreement that currently stands, the District only maintains stormwater, lakes, and fountains. The HOA maintains the lakes and fountains, therefore, there is nothing to revise in the agreement because the District does not maintain anything. Mr. George summarized the agreement and the 4 amendments. A lengthy discussion ensued. Ms. Kulick asked how the District could move forward with the lighting project and plant installation. Mr. George reminded the Board that all projects were subject to HOA approval. Ms. Spence asked Ms. Kulick if the HOA would let the District move forward with the plant installation project for better security around the outer perimeter of the community at no cost to the homeowners because it has already been budgeted and Ms. Kulick stated that the HOA discussed it and rejected the offer to move forward with the project. Ms. Kulik recommended that the District turn over lighting to the HOA and look at the special security powers the District had. Mr. George asked the Board if they would like to proceed with this item.

A **motion** was made by Mr. Hasan, seconded by Ms. Carter and passed unanimously directing Mr. George to NOT investigate turning the FPL lighting over to the HOA and special security powers of the District.

### A RESOLUTION OF THE SONOMA BAY COMMUNITY DEVELOPMENT DISTRICT DESIGNATING MICHAEL J. PAWELCZYK AS THE DISTRICT'S REGISTERED AGENT AND DESIGNATING THE OFFICE OF BILLING, COCHRAN, LYLES, MAURO & RAMSEY, P.A. AS THE REGISTERED OFFICE

**WHEREAS**, Section 189.014, Florida Statutes requires that the Sonoma Bay Community Development District (the "District") designate a registered office and a registered agent, and further authorizes the District to change its registered office and registered agent, at the discretion of the District Board of Supervisors (the "Board"); and

**WHEREAS**, the designation of both a registered office and a registered agent is for the purpose of accepting service of process, notice, or demand that is required or permitted by law to be served upon the District; and

**WHEREAS**, the Board has been informed by the office of District Counsel that there is a need to designate a new registered agent for the District; and

**WHEREAS**, the Board seeks designate Michael J. Pawelczyk as the registered agent for the District, and update the business address of the registered office of the District, as necessary.

### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE SONOMA BAY COMMUNITY DEVELOPMENT DISTRICT, THAT:

**Section 1.** The foregoing recitals are hereby incorporated as findings of fact of the Board.

<u>Section 2</u>. Michael J. Pawelczyk is hereby designated as the registered agent for the District, thereby replacing any previously designated registered agent.

<u>Section 3</u>. The registered office of the District is hereby designated as the office at Billing, Cochran, Lyles, Mauro & Ramsey, P.A., 515 East Las Olas Boulevard, Suite 600, Fort Lauderdale, Florida 33301. The registered office is identical to the business address of the registered agent designated in Section 2 of this Resolution.

<u>Section 4</u>. Pursuant to the requirements of Section 189.014(2), Florida Statutes, the District's Secretary shall transmit copies of this Resolution to the local governing authority or authorities and to the Florida Department of Economic Opportunity.

Section 5. All resolutions or parts of resolutions in conflict herewith are repealed to the extent of such conflict.

<u>Section 6</u>. If any clause, section or other part or application of this Resolution is held by a court of competent jurisdiction to be unconstitutional, illegal or invalid, in part or as applied, it shall not affect the validity of the remaining portions or applications of this Resolution.

<u>Section 7</u>. This Resolution shall be effective immediately upon adoption.
